



INFORMATION PURSUANT TO ARTICLE 13 OF EU REGULATION 2016/679

Dear Candidate,

Pursuant to the regulations in force concerning the protection of personal data, we inform you **that in the framework of the selection for a possible collaboration for scientific research projects at the Centro Cardiologico Monzino (CCM)**, subject to your consent, information concerning you considered personal data* and potentially also information considered special data** will be acquired. The information will be acquired through your curriculum vitae, including any certificates, titles and any document and declaration useful for the evaluation.

The data will be processed using both manual and computerised means, by specially authorised personnel in such a way as to guarantee the security and confidentiality of the data, in compliance with current legislation on the protection of personal data. Personal data will be stored for 12 months. Should it be necessary to involve parties external to the CCM (companies or professionals) this will only take place after specific agreements with clauses safeguarding your rights regarding the protection of personal data.
